Local Safe Passing Ordinances:

- Despite long-term and state-wide lobbying by cyclists, the Michigan Legislature has not passed a Safe Passing Law.
- The Committee decided that we will work on a local level to get Tri-County communities to pass their own Safe Passing Ordinances.
- President Pat Kelley gave us the o.k. to proceed.
- A web site (<u>www.biketcba.org/safepassing</u>) detailing the campaign is up.
- Work has begun on crafting a model law.

• Bicycle Issues Concerning the Michigan/Grand River Avenues Corridor – Tim Potter and Mike Unsworth had a discussion

with new CATA officials Brad Funkhouser (Asst. Executive Director) & Elizabeth Hude (System Planner) and Mid-Michigan Environmental Action Council's Theresa Lark—This was a general discussion in which Mr. Funkhouser said that he will talk to all interest groups, including the cycling community, in its future planning.

- Tri-County Regional Planning Commission's Non-Motorized Transportation Plan—Tim Potter, Steve Leiby, and Mike Unsworth attended the kick-off meeting. Tim and Mike were named to the Working Group.
- Public Hearing on the Ingham County Parks Commission's 2017-2021 Draft Master Plan—Several members attended. Many of the Plan's goals featured bicycle-friendly projects
- Governor's Pedestrian Bicycle Safety Action Team Mike Unsworth & Tim Potter represented TCBA at this quarterly meeting which covered various aspects of non-motorized safety



We at Birch Shores Resort are Friends of Sleeping Bear Dunes and also Contributors and Sponsors of The Trail.

We have decided that the rest of the Membership could be interested in more information about biking and hiking The Sleeping Bear Heritage Trail, 2 miles north of our Guest cabins on Little Glen Lake. This paved, 10 feet wide nature and bike trail, is being expanded from the current 18 miles to about 39 miles, from Northport to Platte Lake. It parallels M-22 & M-109 at present and has few road crossings.

This is the only bicycle trail in Sleeping Bear Dunes National Lakeshore. In winter it is groomed for cross-country skiing (both classic and skating styles) and snowshoeing. It is mostly paved, but has a short section of packed gravel through the Port Oneida Rural Historic District. The trail spans about 18 scenic miles between Empire and Basch Road, with the Dune Climb, historic Glen Haven and the town of Glen Arbor along its route.

The beautiful fall Color season is fast approaching and the M-22 stretch has been nationally ranked for the Fall color.
