SummerTour 2018 –Register Now!

Don't forget about SummerTour for your bicycling fun and adventure. Tour information is available online and registration is still open at biketcba.org/summertour.

SummerTour 2018 will include suggested and mapped out road routes with noted stops for lunch and points of interest. Maps with reviewed routes are included with registration and the starting point this year offers many optional routes either from the campground or a short drive and ride away.

These options include the usual bicycle rides on local roads as well as "Drive and Ride", where you drive to a trailhead and ride your bicycle on the paved White Pine and Pere Marquette Trails. This year SummerTour has a new option that you "Ride Your Own Story." You make your own agenda as you choose. You might decide not to follow the daily maps and find your own bicycling adventure.

Afterward, return to camp and share your adventures of the awesome day you had while enjoying a delicious catered meal or with s'mores at an evening campfire. Whether you choose to ride the suggested daily routes with maps or plan your own route, you will have had a splendid day on

paved roads, trails, gravel or perhaps some offroad adventure.

There are several trails, of varying lengths and difficulties, around Cadillac for mountain bicycles and fat tire bicycles. Cadillac is a short drive from Marion. We obtained maps for many of these trails for those who will "Ride Your Own Story.

It's going to be a great SummerTour with quiet roads and trails. We're staying at the lovely and wonderful Veteran's Memorial Park Campground in the Village of Marion for five days and four or five nights. The campground has free WIFI and two ice cold artesian wells for filling your water bottles.

There are also canoeing and kayaking rental opportunities close by, on either the Muskegon River or the Pine River. Or bring your own kayak and paddle right in Marion at the Mill Pond. Check-out our web site at biketcba.org/summertour for registration or full information about SummerTour 2018.

Bike Safety Campaigns

In a January 15 hearing the House Transportation and Infrastructure Committee was supportive of an additional hour being added to Drivers' Education curriculum that would cover vulnerable road users. As for Safe Passing Distance, the Committee is struggling with how precise (or imprecise) proposed language should be. There's no timetable on when the Committee will vote on either of these measures.

The Senate Transportation Committee has favorably voted on its versions of Drivers' Education & Safe Passing Distance bills and sent them to the full Senate. There's no timetable on when the Senate will vote on it.

The Advocacy Committee will continue to ask local communities to pass their own Safe Passing Distance ordinances. It is also working on a local safety campaign which will utilize material from People For Bikes and a Grand Rapids effort.

Bicycle Services to Homeless

Mike talked with the Lansing City Rescue Mission (CRM) and learned that its clients' "biking season" is from March through

November. CRM holds a "Services Fair" every first Tuesday from 8-10 a.m.; Mike will go to the Feb. 6 meeting to gauge interest.

MDOT Issues

Communications with MDOT's Lansing Service Center resulted in a meeting with MDOT officials on February 1. Topics to be discussed will be the proposed "Superstreets" project on Saginaw between Park Lake and Marsh Road; MDOT participation in regional bike safety meetings; a possible "fix" for the Saginaw/ Grand River split; the I-96 exit at Okemos Road; and extending the buffered bike lanes on West Saginaw in Lansing.

2017 Annual Report TCBA Advocacy Committee

Organizational matters:

- ~ 13 people regularly attend the Committee's monthly meetings or work on projects. (see end of report)

-Online activities:

Discussion list has 59 members

Facebook has 238 followers.

Twitter site is following 92 tweeters, 14 followers and 35 likes.

-Two long-time members left the committee. Nancy Krupiarz retired and moved to Petoskey. Bob Lovell stepped down due to the press of other activities.

Safe Passing laws and ordinances:

-Separate web page: www.biketcba.org/safepassing, incorporates the need for ordinances, a model law, press releases, links to resources and video

-Advocacy members attended hearings of the Legislature on this topic. -In May Mike Unsworth gave a presentation to East Lansing City Council. Despite a favorable reception, there has been no movement in East Lansing.

Ingham County Trails Millage:

-Committee members Steve Leiby, Lenny Provencher, Dean Brailey and Mike Unsworth attended numerous meetings on this project.

-Successfully lobbied to ensure the bulk of the funds go to actual trailrelated projects.

Rides of Silence-- 250+ bicyclists participated in the nine-mile ride from Wells Hall Plaza at Michigan State University campus to Michigan State Capital .

Non- Motorized Transportation Plans— Governments are required to have NMT Plans as part of overall Master Plans to receive federal funds. Committee members worked with City of Lansing, Tri-County Regional Planning Commission, and Bath & Delta Townships in reviewing their plans.

Advocacy Members Represented TCBA at Meetings/Events:

- -Pedestrian and Bicycle Committee of the Michigan Dept. of Transportation's University Region--Goal of quarterly meetings is to share information to improve bicycle and pedestrian safety: best practices, lessons learned, upcoming projects, new approaches, successes, etc.
- -Quiet Waters Symposium—staffed a table
- -MSU Bike Friendly America Conference—Tim Potter and Dean Brailey attended
- -Governor's Traffic Safety Advisory Commission's Bicycle and Pedestrian Task Force
- -Friends of the Lansing Regional Trails annual meeting
- -MDOT "Training Wheels" workshop-- Mike Unsworth attended an exhaustive meeting that had dozens of good ideas in creating bike-friendly infrastructure.
- -Mike Unsworth, Lenny Provencher, and Dwight Washington staffed a TCBA table and displayed bikes at the June 5 Eaton Rapids Schools Health Fair.
- -Shaping the Avenue workshops (http://shapingtheavenue.com) -- Committee members found most planners and participants are interested in walkable/bikeable facilities for Michigan Avenue. Many favored protected bike lane options.
- -Tri-County Regional Planning Commission's Public Open House: "Moving Mid-Michigan 2045"—Several members attended sessions.

Advocacy on Twitter: September; Advocacy feed https://twitter.com/TCBA Advocacy! Ann Siegel and Mike Unsworth are monitors. Goal is visibility in the community & media by showing we are a good community partner. We want cycling to be integral in the enjoyment of people's lives. Additionally, posting Advocacy developments, following any organization or agency making transportation decisions and relevant media in the area with emphasis on bike-car incidents.

Survey of Political Candidates -

Advocacy Committee e-mailed surveys to 43 candidates for local office in Eaton and Ingham Counties (Clinton County had no elections.) Twelve

candidates responded for a response rate of 27%. Eleven supported bicycle-friendly issues.

Speakers Bureau – Presentations on "Bicycles: Frequently Asked Questions" given to Bath Lions and South Lansing/Holt, St. Johns & Dewitt Sunrise Rotary clubs

Complete Streets Ordinance for Ingham County—County established a Special Complete Streets Committee that drafted an ordinance the County Commission enacted.

MDOT's practice of blocking crossing of medians for so-called "Superstreet" projects (https://en.wikipedia.org/wiki/Superstreet)
State-wide policy—Committee is working with League of Michigan Bicyclists on a statewide effort to reverse practice

Proposed Business I-69 Corridor in Meridian and Bath Townships—TCBA sent MDOT its opposition to its current plan. Committee is working with Bath and Meridian Townships on a true Complete Streets treatment to the corridor

Other Projects:

- -Bike safety: Committee is beginning a publicity campaign with billboard campaign
- -2018, work will start for town hall meetings in Clinton, Eaton, and Ingham Counties to bring together local law makers and public safety officials to discuss improving bike safety
- -Cyclists' Happy Hours—TCBA co-sponsored two at Lansing Brewing Company in late winter and fall.
- -Cargo Bike Rendezvous at Costco—On November 4, three cargo bike riders plus five supporters showed up. Rain canceled our trip to Newton Road. Costco was informed that it needs signs to direct cyclists to bike parking.
- -Bike Outreach Services to Homeless and Low-Income Cyclists—work will begin in early 2018

Proposed Bus Rapid Transit on the Michigan/Grand River Avenues Corridor – In January CATA decided not to pursue this project.

Bike Shorts Film Festival— Due to the demise of the Kalamazoo Bike Festival, Kevin Schumaker led the effort to have one in early 2018.

Purpose: The purpose of the ride incentive program is to encourage club members to participate in TCBA recreational rides. Ride Incentive "miles earned" are miles ridden only on TCBA sponsored rides.

Ride Classes

Established to enable riders of similar abilities to ride together, classes are based on average overall ride pace (speed), as follows:

Class	Pace (avg speed on a "level" route with no wind)	
Class A+	19+	
Class A	17-19 mph	
Class B	14-17 mph	
Class C	12-14 mph	
Class D	Up to 12 mph	
Class Z	Over 40 miles at riders' own pace	
Class M	Mountain bike "single track" rides	
Class G	Gravel Road Rides, plus "speed class" (A-Z) of the ride	

Responsibilities of Riders and Ride Leaders Ride Leaders

- Please follow the rules of the road; same roads, same rules!
- Scout the route and create accurate maps and/or cue sheet defining the route.
- Provide a Rider Sign-in Sheet. Please keep your Rider Sign-in Sheets until the season ends and get these to a TCBA Board Member or the "Mileage Coordinator
- All rides should start from a publicly accessible location.
- Provide notice of the ride on the biketcba.org Event Calendar. Send your desired ride to ridecoordinator@biketcba.org Information in the notice shall include the leader's name and contact information (phone number and/or e-mail address), date and time, starting location, ride class, and approximate distance. Weather conditions under which a ride will not occur should be stated. The starting point should provide adequate parking for a reasonable number of expected riders; and, if private property is used for this purpose, the ride leader is responsible for securing permission from the property owner or manager.
- Unless the ride notice states a requirement for lights, rides should be scheduled during daylight hours. There should be sufficient time to do the ride at the pace defined by the ride class plus an allowance for planned stops and unforeseen mechanical problems.
- Provide a reasonable number of maps or cue sheets for the anticipated number of entrants and ride sign in sheet. follows:

General Rules

- The ride calendar year is December 1st of the previous year through November 30th of the current year.
- Club rides must be submitted to the <u>ridecoordinator@biketcba.org</u> to be posted on the biketcba.org Event
 Calendar. Ride information must be submitted so that it appears on the updated ride format for at least two
 (2) days prior to the ride. The update schedule and deadlines are set by the Ride Line Coordinator and may
 vary by season.
- Any rides starting within the state of Michigan, do not require Board approval but must be submitted via the current process to be published.
- Start locations outside the State of Michigan require board approval.
- No club rides shall be scheduled during the T-shirt Ride, Ride of Silence, or club-sponsored social activities (picnic).
- Rides of the same class leaving from the same general location must be at least one hour different in starting time.
- Helmets are required on all club rides; personal audio devices are prohibited.
- There is only one ride leader per ride.
 E Bike riders using Class 1 and 2 e-bikes* are allowed to participate in the TCBA Ride Incentive program.
 Please see the definitions of these categories at the end of this document.

2018 TCBA - Ride Incentive Program continued

Incentive Eligibility

TCBA members in good standing may accumulate mileage points. Riders earn 1 point per route mile and/or "home mile" ridden. Ride leaders receive ride mileage as well as ride leader points (100 points for Class D and M) and 50 points for all other ride classes); *Mountain Bike Riders earn Ride Incentive Points for all publicized TCBA Mountain Bike Rides on single track. Because mountain biking is more technical, typically at slower speeds and less miles traveled in a similar time then road biking, a conversion will be used; 1 mile of single track will equal 3 miles toward the Ride Incentive Pro-

- If there are no other riders, the ride leader receives the ride mileage plus 10 leader points.
- "Home miles" are miles ridden to and from TCBA rides, meetings, social events, or invitational tours based on the safest distance to these events from the rider's home.
- If a ride leader fails to participate in a scheduled ride, another rider may assume leadership and will be credited with the leader points.
- Members are responsible for documenting participation in TCBA rides on any official club ride sheet. Entry shall include member's name, date, events name, and distance.
- The TCBA Board is responsible for equitable enforcement of the ride program.

Ride Incentive Levels; All mileage recorded must be on TCBA Club Rides or TCBA Sponsored Rides/Tours for the Ride Incentive Awards

Level 1 2018+ miles ridden including Home/Leader miles

Level 2 1250 to 2017 miles ridden including Home/Leader miles

Level 3 501 to 1249 miles ridden including Home/Leader miles

Level 4 up to 500 miles ridden including Home/Leader miles, or have ridden on 5 club rides/tours

*E-Bike definitions from League of Michigan Bicyclists/State of Michigan; PA 139 goes on to divide e-bikes into three

Class 1 An electric bicycle that is equipped with an electric motor that provides assistance only when the rider is pedaling and that disengages or ceases to function when the electric bicycle reaches a speed of 20 miles per

Class 2 An electric bicycle that is equipped with a motor that propels the electric bicycle to a speed of no more than 20 miles per hour, whether the rider is pedaling or not, and that disengages or ceases to function when the brakes are applied.

Class 3 An electric bicycle that is equipped with a motor that provides assistance only when the rider is pedaling and that disengages or ceases to function when the electric bicycle reaches a speed of 28 miles per hour. Class 3 e-bikes are excluded from the TCBA Ride Incentive mileage accumulations.
