CARGO BIKE RENDEZVOUS AT THE NEW EAST LANSING COSTCO

At 1 P.M. on Saturday, November 4, bicyclists from near and far are called to pedal their favorite cargocarrying mount to the new East Lansing Costco Wholesale, 2540 E Saginaw St. (Intersection of Park Lake Road and Saginaw/Business I -69).

Last year Costco told the City of East Lansing that their new store wouldn't need bike racks because their customers always drive. TCBA urged the East Lansing City Council to have Costco follow the City's ordinances and put in bike racks. The Council agreed and required Costco to install the racks as part of construction.

Kiddie trailers also make great cargo haulers and are much cheaper than cargo bikes if any of you are needing to get something for your Costco shopping runs.

Let's now demonstrate to Costco that bicyclists will pedal and shop at their new store!

BICYCLE SAFETY BILLS ADVANCE IN MICHIGAN SENATE by Mike

On September 28, the Senate Judiciary Committee unanimously voted to send to the Senate a package of bills that will increase bicyclist safety on Michigan roads.

The bills include:

☐ A five-foot passing buffer ☐ Drivers' education curriculum which would include specific instructions on interacting with cyclists

☐ Ban using all hand-held devices while driving

☐ Increase penalties for texting while driving & Increase penalties for texting while driving & Increase and a death to a felony punishable by up to five years in prison

-Attorney and TCBA member Bryan Waldman helped League of Michigan Bicyclists Director John Lindenmayer brief the Committee on the details of the bills. Over the past several years Bryan has done yeoman work on bicycle issues on local and state levels.

-In verbal comments, Advocacy Committee Chair Mike Unsworth summarized TCBA President Pat Kelley's September 22 letter to the Committee (see below). Several TCBA members also attended the hearing.

-The bills – SB123-124, 170, and 580-581—now go to the full Senate. You can follow their progress at https://www.legislature.mi.gov.

September 22, 2017

Dear Senate Judiciary Committee:

The Tri-County Bicycle Association (TCBA), located in Lansing, Michigan is pleased to support the bicycle safety package before this committee. We strongly urge you to vote in favor of SB 123, 170, and 124. These bills create clear standards for how to safely pass a bicyclist and will improve driver's education in Michigan to put a greater emphasis on bicycle safety.

Additionally, we would like to express our support for SB 580 and 581 strengthening distracted driving penalties in Michigan. TCBA has over 850 members who bicycle thousands of

miles each year on Michigan roads. Many members are bicycling less due to the number of car/bike encounters. In every one of these "encounters" with a car's driver, the bicyclist lose. Many of our members are afraid to ride on Michigan roads.

As you may know, TCBA is the club that is responsible for organizing annually the Dick Allen Lansing to Mackinaw (DALMAC) bicycle ride from Lansing to the Mackinaw each Labor Day weekend. DALMAC has about 1,400 riders, on Michigan roads for this ride each year. We are proud of the DALMAC ride, and our ability to have sponsored DALMAC for 47 years. The number of riders on this epic tour has been decreasing because many riders are fearful for their lives based on some drivers' behaviors. The 5 foot passing distance would be of great benefit to bicyclists, and other vulnerable road users. Having new/young drivers become educated about how to safely pass people on bicycles is another safety aspect many of our members' desire, along with increased penalties for distracted driving.

TCBA believes that more education will assist drivers' with how to interact with bicyclists. Please take note of Grand Rapids' recent "Driving Change" campaign featured their five-foot safe passing ordinance as a basis for educating drivers in how to safely interact with bicyclists with great success. The effort resulted in an 82% reduction in fatal or serious

Please consider vulnerable peoples safety, over politics. Help make using our roadways safer for all of us. TCBA urges you to support and pass SB 123, 170, and 124, and SB 580 and 581. Michigan is one of only eleven states without a law specifically requiring motorists to pass bicyclists safely!

Tips for Bicyclists & Drivers on the Go

Most SHSOs offer tips to help bicyclists and drivers safely share the road that are disseminated via cards, flyers, posters and/or websites. SCAG's Go Human campaign offers the following tips to...

Bike safely

- Always ride in the same direction as traffic flow.
- Stop at red lights and stop signs. Traffic signs and signals apply to bicyclists, too.
- Be predictable by signaling your intentions and only change lanes when it is safe to do so.
- When riding at night, use a front and rear light to make yourself visible.
- Wear a helmet to reduce the risk of injury. (Riders under 18 in California are required by state law to wear helmets.)
- Slow down and take care around people walking on sidewalks and in crosswalks.
- Be alert. Put your cell phone away, keep your eyes on the road, and watch for people driving and walking.

Drive safely

- Slow down. Drive at or below the posted speed limit. Be alert for people walking, bicycling, in wheelchairs or on skateboards.
- Look twice for people biking or walking before making a turn. Always come to a complete stop before turning right on red.
- Allow at least 3-feet when passing people on bikes.
- When there is not enough room for a bike and a car to safely ride side-by-side, bicyclists are allowed to use the entire lane. Change lanes and pass only when it is safe to do so.
- Be alert. Put your cell phone away, keep your eyes on the road, and watch for people biking and walking.

Message from President, Pat Kelley

Several of you have asked how to check your year-to-date ride mileage on the TCBA website.

To do this, log into the TCBA website. Click on the red button to the right of your name displayed at the upper right of the main website page. Click on "Profile." A menu with many options will be displayed. Under "Website", click on "My Rides."

A list of all of the rides in which you have participated this year will be displayed. For each individual ride, the following will be displayed: ride miles, leader bonus miles, home miles, and total miles.

There are only two ways to obtain a year-to -date, cumulative total of one's TCBA mile-

age: (1) manually total up the miles or (2) highlight the entire "My Rides" matrix, copy the highlighted area, paste the matrix into a Microsoft Excel spreadsheet, and then sum the "total miles" column.

Also, for you "Smartphone" users, there is a new app available for free to download for our website. Go to your app store and search "Tri-County Bicycle Association" (make sure that you have the "-" in your search criteria) and you can download the app. Once you have downloaded this app you will need "log into" the site per usual to use it, but the site remembers your login info so you will not have to "sign- in" each time you use this new app.

Bicycle Safety Bills in the Michigan Senate – See separate article in this issue

Proposed Business I-69 Corridor Median Closures

-At its presentation on the "I69BL Corridor Improvements Projects" (August 7, 2017) Bath Township Board of Trustees meeting, the Michigan Dept. of Transportation (MDOT) proposed blocking the crossing of Business I69 from Newton and Towner roads (which are in Meridian Township but provide access to Bath Township). MDOT said that the projects are preliminary and are subject to change.

-The Bath Trustees told MDOT that access to Newton and Towner is essential for Non-Motorized Transportation in the area. Advocacy Committee member Tim Potter who is also Vice Chair of the Meridian Township Transportation Committee will bring this matter to the attention of Township officials. Tim and Advocacy Committee member Dan Stockwell will also contact Corridor businesses on how the median closures will prevent customers from safely accessing their enterprises.

Ingham County Trails Millage Diversion -It appears that the diversion of millage funds to non-trails projects will not take place. The County Services Committee (CSC) approved the 2018 budget which did not include the proposed diversion. At the CSC meeting, the Park Dept. representa-

tive said that his Department accepted the budget. The full County Commission will vote on it at its October meeting.


